**ORDER REGARDING MEDIATION WITH PLAINTIFF GROUPS  
REGARDING THE ALLOCATION ISSUE ON APRIL 15-16, 2021**

Lead Resolution Judge Joanna I. Tabit, Resolution Judge Jay M. Hoke, and Resolution Judge Gregory L. Howard **ORDER** mediation with the Plaintiff Groups identified on the attached list and their counsel regarding the allocation issue **on April 15, 2021, and April 16, 2021**. Mediation will begin at 9:00 a.m. each day.

Because the COVID-19 pandemic requires the Resolution Judges, the Plaintiffs, and Plaintiffs' counsel to practice social distancing, the Resolution Judges will be conducting mediation by video conference. All Plaintiffs and Plaintiffs' counsel must download the Microsoft Teams platform to participate in mediation. The Mass Litigation Manager will send Microsoft Teams Meeting invitations to the mediation participants for each day of mediation.

Additionally, because of the large number of Plaintiffs and Plaintiffs' counsel, the Resolution Judges have divided the Plaintiff Groups with whom they are mediating over the course of the two-day mediation.

One designated Plaintiff Representative with authority to negotiate on behalf of each Plaintiff named in the above-listed Plaintiff Groups as well as Lead Counsel for each of the above-listed Plaintiff Groups shall participate in mediation on April 16, 2021.

**MEDIATION CONTACT SHEET:**

Plaintiffs' Liaison Counsel shall work with Plaintiffs' counsel to provide the Mass Litigation Manager with separate contact sheets for each day of mediation **no later than April 5, 2021**. The contact sheets for each day of mediation shall contain:

1. the name of each Plaintiff and the name, telephone number and email address of the designated Plaintiff Representative participating in mediation that day; and
2. the name, telephone number and email address of Lead Counsel for each Plaintiff Group participating in mediation that day.

**EX PARTE CONTACTS**

Before, during and after mediation, the Resolution Judges may find it necessary and useful to communicate with one or more parties outside the presence of the other party or parties.

**CONFIDENTIALITY**

The parties are reminded that any written statement or discussion regarding mediation is confidential; shall not be used in the present litigation or in any other litigation (whether

presently pending or filed in the future); and shall not be construed as or constitute an admission. Breach of this provision shall subject the violator to sanctions.

### **OBLIGATION OF GOOD FAITH PARTICIPATION**

Mediation participants shall be available and accessible throughout the mediation process to the Resolution Judges and to their respective co-counsel.

No party may be compelled by this Order, the Mass Litigation Panel, or the Resolution Judges to resolve a dispute involuntarily or against the party's judgment. However, the Resolution Judges expect the parties' full and good faith cooperation with the mediation process and expect the participants to be prepared to participate fully, openly, and knowledgeably in a mutual effort to examine and resolve issues. The Resolution Judges encourage all participants to keep an open mind, to reassess their previous positions, and to find creative means for resolving the dispute.

### **MEMORIALIZATION OF SETTLEMENT**

If the parties reach a resolution of their dispute, the parties shall memorialize the general terms of their settlement in a written memorandum signed by counsel. A copy of the settlement memorandum shall be provided to the Resolution Judges prior to conclusion of the mediation.

### **IMPOSITION OF SANCTIONS**

**All counsel are reminded of their obligations to read and comply with this Order.**

To avoid the imposition of sanctions, counsel shall advise the Resolution Judges immediately of any problems regarding compliance with this Order.
