- 1. Overview of cases pending before the Mass Litigation Panel;
- 2. Status of In Re: National Prescription Opiate Litigation, MDL 2804, in the United States District Court for the Northern District of Ohio Eastern Division, including Judge Polster's Order Certifying Negotiation Class and Approving Notice;
