The parties stipulate and agree that all disclosures, motions, responses, and replies required under the parties' Agreed Amended Case Management Order will be e-mailed to opposing counsel in addition to service permitted under the West Virginia Rules of Civil Procedure in recognition of the condensed deadlines agreed to by the parties.

All other aspects of the Case Management Order previously entered in the Oak Grove Trial Group that are not explicitly addressed above, including the dates of Hearing on Dispositive Motions and Motions *in Limine* (**10:00 a.m. on July 30, 2021**), Pretrial Conference (**10:00 a.m. on July 30, 2021**), and Trial (**9:00 a.m. on August 16, 2021**), remain in effect.
