ORDER TRANSFERRING AND CONSOLIDATING  
THE MOUNTAIN STATE UNIVERSITY LITIGATION  
TO THE CIRCUIT COURT OF KANAWHA COUNTY, WEST VIRGINIA

Pursuant to West Virginia Trial Court Rule 26.07(a), with the advice and consent of the Mass Litigation Panel ("Panel"), The Honorable Alan D. Moats was assigned as Lead Judge presiding in the Mountain State University Litigation on December 12, 2012. Pursuant to West Virginia Trial Court Rule 26.08(b), and with the advice and consent of the Panel, it is **ORDERED** that the Mountain State University Litigation be consolidated under the style, "*In re: Mountain State University Litigation*, Civil Action No. 12-C-9000, in the Circuit Court of Kanawha County, West Virginia" in order to facilitate the Panel's case management and trial methodologies.


It is further **ORDERED** that the Mountain State University Litigation be transferred to the Circuit Court of Kanawha County, West Virginia, and that all court files for currently pending cases listed or described in Exhibits A attached to the Administrative Order entered by the Supreme Court of Appeals of West Virginia on December 6, 2012, be transferred to the Circuit Court of Kanawha County, West Virginia, **on or before January 4, 2013**. The Clerk of the Circuit Court of Kanawha County, West Virginia, will coordinate with the Clerks of the Circuit Courts of Cabell


County, Putnam County and Raleigh County, West Virginia, the Mass Litigation Manager, and the office of the Administrative Director of the Supreme Court of Appeals to accomplish the orderly transfer of court files.

The Presiding Judges will conduct a Status Conference in the Mountain State University Litigation at **10:00 a.m. on February 1, 2013, in Courtroom Four**, also known as the Ceremonial Courtroom, on the Second Floor of the Kanawha County Courthouse, at 407 Virginia Street, East, in **Charleston, West Virginia**.

The Clerk of the Circuit Court of Raleigh County, West Virginia, is **ORDERED** to forward a certified copy of this Order to the Mass Litigation Manager and the Clerks of the Circuit Courts of Cabell County, Putnam County, and Kanawha County, West Virginia. The Clerks of the Circuit Courts of Circuit Courts of Cabell County, Putnam County, Kanawha County, and Raleigh County, West Virginia, are further **ORDERED** to provide copies of this order to all parties of record or their counsel in the currently pending cases listed or described in Exhibits A attached to the Administrative Order entered by the Supreme Court of Appeals of West Virginia on December 6, 2012.
