ORDER GRANTING MOTIONS TO WITHDRAW AS COUNSEL

On the 20th day of September 2019, Scott S. Segal and C. Edward Amos, II appeared on behalf of Plaintiff S.S., and Kirk Lightner appeared on behalf of Plaintiffs S.H., B.B., and H.H. Plaintiffs S.S., S.H., B.B. and H.H. did not appear at the hearing. Defendant Cardinal Health 414, LLC, also appeared at the hearing by counsel. Based upon the written submissions and arguments heard, the Court **GRANTS** the Motions to Withdraw as Counsel for Plaintiffs in the above-styled cases (Transaction IDs 64092243, 64193985, and 64150317). The Court will enter a separate Order specific to Plaintiff S.S., Civil Action No. 18-C-140 RAL.

Within thirty (30) days from the entry of this Order, Plaintiffs S.S., S.H., B.B. and H.H. shall notify Kim Fields, the Mass Litigation Manager, by telephone: (304) 340-3991, or by email message: kim.fields@courtswwv.gov, whether they have retained new counsel, will proceed *pro se*, or they intend to dismiss their civil action. If Plaintiffs do not comply with this Order by

contacting Kim Fields within 30 days of entry of the Order, Plaintiffs' cases may be subject to default and may be dismissed by the Court.

The Court **ORDERS** Plaintiffs S.S., S.H., B.B. and H.H. to appear in person or through new counsel at **1:00 p.m. on December 6, 2019**, in Courtroom Four, also known as the Ceremonial Courtroom, on the second floor of the Kanawha County Courthouse, located at 409 Virginia Street, East, in Charleston, West Virginia, to report to the Court whether they intend to proceed with their civil actions.

A copy of this Order is this day served electronically on all counsel of record in the above-styled cases via the File & Serve*Xpress* system. The Court **ORDERS** Plaintiffs' counsel to mail a copy of this Order to Plaintiffs S.S., S.H., B.B. and H.H. at their last known addresses via U.S. mail, and to file and serve a notice of compliance with the Court's Order in the above-styled civil actions setting forth Plaintiffs' last known mailing addresses.

It is so **ORDERED**.
