**DISMISSAL ORDER**

On February 8, 2019 came the Plaintiff and Defendant Michael Baker International, Inc. ("MBI"), by counsel, and represented to the Court that all claims and controversies between Plaintiff and MBI have been compromised and settled, and that the settlement has been closed and concluded. Whereupon, Plaintiff and MBI jointly move the dismissal of MBI with prejudice as to all claims which have been, or which might have been, asserted by the parties herein.

Hearing no objection and perceiving of none, upon the parties' representations and joint motion, it is accordingly ORDERED that MBI be, and it is hereby, DISMISSED WITH PREJUDICE from this action as to all claims.

Furthermore, based on the representations of Plaintiff and MBI, by their counsel, the Court finds that the settlement in this matter between the Plaintiff and MBI is a "good faith

settlement,” and therefore the Court hereby ORDERS that any and all cross-claims that have been alleged against MBI in this civil action are also hereby DISMISSED WITH PREJUDICE.

It is so ORDERED.
