**AGREED ORDER DISMISSING
NOVEL GEO-ENVIRONMENTAL, LLC, WITH PREJUDICE**

On a prior day came the Plaintiff Central West Virginia Regional Airport Authority, Inc. (“Plaintiff”) and came Defendant Novel Geo-Environmental, LLC (“Novel”), by their respective counsel, and represented to the Court that all claims and controversies between them had been compromised and settled, in good faith, by way of a confidential settlement agreement.

Whereupon, Plaintiff and Novel jointly moved this Court for the dismissal, with prejudice, of all claims and cross-claims which were, or which could have been asserted by or against Novel in this action.

Hearing no objection and perceiving of none, and upon the parties’ representations made at the February 8, 2019, pre-trial hearing in this matter, and upon their joint motion, it is accordingly **ORDERED** that:

1. All claims asserted by Plaintiff against Novel in this matter are dismissed, with prejudice.

2. All cross-claims asserted by co-defendants against Novel in this matter are dismissed, with prejudice.

3. All cross-claims asserted by Novel against co-defendants in this matter are dismissed, with prejudice.

4. Novel is hereby dismissed and removed as a party defendant to this action, with prejudice.

5. Plaintiff and Novel shall bear their own costs of suit and attorneys' fees.

It is so **ORDERED**.
