**SECOND AMENDED CASE MANAGEMENT ORDER
REGARDING DAMAGES ONLY TRIAL**

Having reviewed *Defendants' Joint Motion for a Ten Day Extension of Defendants' Expert Witness Disclosure Deadline* (Transaction ID 61394486), the *Keystone Apostolic Church's Response* (Transaction ID 61443258) and *Defendants' Joint Reply* (Transaction ID

61454926), the Presiding Judges **GRANT** Defendants' Joint Motion for another modification of the *Case Management Order Regarding Damages Only Trial* (Transaction ID 61341803) to extend Defendants' Expert Witness Disclosure Deadline by 10 days, from January 2, 2018, to **January 12, 2018.**

The Presiding Judges **DENY** Keystone Apostolic Church's request for a 10 day extension of time from December 15, 2017, through December 25, 2017, to identify expert witnesses. All other deadlines set forth in the *Case Management Order Regarding Damages Only Trial* (Transaction ID 61341803) remain in full force and effect, including but not limited to, the March 12, 2018, pretrial conference and hearing on dispositive motions and motions *in limine*, and the March 19, 2018, trial. Any objection or exception to this Order is noted for the record.
