**THIRD AMENDED CASE MANAGEMENT ORDER  
REGARDING DAMAGES ONLY TRIAL**

At the request of the Resolution Judges who conducted mediation in these cases on February 1-2, 2018, the Presiding Judges hereby extend the following deadlines by seven (7) days to facilitate further negotiations between the parties:

1. **DEADLINE FOR FILING MOTIONS IN LIMINE: February 15, 2018**
2. **DEADLINE FOR RESPONSES TO MOTIONS IN LIMINE: March 1, 2018**
3. **DEADLINE FOR REPLIES TO MOTIONS IN LIMINE: March 8, 2018**

WVRE 103(c) requires that all motions in limine should be determined prior to trial, where practicable. This Court will not consider motions in limine on the day of trial without good cause shown.

4. Exhibits, Witness Lists and Deposition Designations shall be exchanged **no later than February 16, 2018**, with any objections thereto **no later than March 2, 2018**.

All parties shall meet and confer **no later than March 5, 2018**, to resolve objections to witnesses, exhibits and deposition designations.

All other deadlines set forth in the *Case Management Order Regarding Damages Only Trial* (Transaction ID 61341803) remain in full force and effect, including but not limited to, the March 12, 2018, pretrial conference and hearing on dispositive motions and motions *in limine*, and the March 19, 2018, trial. Any objection or exception to this Order is noted for the record.

It is so **ORDERED**.
