ORDER

The Morgan County Commission has directed that the Morgan County Courthouse be closed on Friday, October 10, 2014 at noon, due to the Morgan County Apple Butter Festival. The festival will result in a large number of individuals surrounding the Morgan County Courthouse inasmuch as there will be a parade and other events occurring in proximity to the Courthouse, which could hamper, delay significantly, disrupt, or negatively affect court proceedings.

Therefore, pursuant to Article VIII, § 6 of the Constitution of the State of West Virginia, and pursuant to the provisions of West Virginia Code § 2-2-2, the undersigned Chief Judge hereby designates October 10, 2014 from noon on an emergency day, and does therefore

ORDER that at noon on October 10, 2014, all courts of Morgan County, West Virginia shall be closed. It is further

ORDERED that Magistrates and Mental Hygiene Commissioners shall perform their on-call assignments at the closest secure governmental facility.

In connection with this Order, all filing deadlines shall be extended until the courts resume operation. It is further

ORDERED that the Clerk of this Court send an attested copy of this Order to the Administrative Office of the West Virginia Supreme court of Appeals; Jennifer Bundy, the West Virginia Supreme Court Public Information Officer; all Family court Judges for Morgan County;

all Magistrates of Morgan County; the Morgan County Magistrate Court Clerk; all Mental Hygiene Commissioners of Morgan County; the Sheriff of Morgan County; all attorneys with an office in Morgan County; the Chief Probation Officer of the Twenty-Third Circuit; the President of the County Commission of Morgan County, and to all Circuit Judges of the 23rd Judicial Circuit comprising of Berkeley, Jefferson, and Morgan Counties. It is further

ORDERED that a copy of this Order be posted on the Main Entrance door to the Morgan County Courthouse.
