ORDER

On the 15th day of April, 2011, came the defendant, **TIMOTHY RAY SUTHERLAND**, having been found guilty by a jury on the 17th day of March, 2011, of the felony offense of Murder in the First Degree, a provable offense as contained in said Indictment No. 10-F-328, appeared in Court in the custody of the Sheriff, together with his counsel, Ronni Sheets and Justin Collin, and also came the State of West Virginia by Don Morris and Maryclaire Akers, Assistant Prosecuting Attorneys in and for Kanawha County, West Virginia.

THEREUPON, it was demanded of the said **TIMOTHY RAY SUTHERLAND**, if anything he had or knew to say why the Court should not now proceed to pronounce the sentence of the law against him, and no valid reason being offered or alleged in delay of judgment, it is considered by the Court as follows:

10-F-328: That the defendant, **TIMOTHY RAY SUTHERLAND**, be committed to the custody of the West Virginia Department of Corrections for the rest of his natural life.


Therefore, the effective sentence date is: December 30, 2009.

It is further ORDERED that the proper officer do, as soon as practicable, remove and safely convey the said TIMOTHY RAY SUTHERLAND from the Western Regional Jail to the custody of the West Virginia Department of Corrections, to be kept imprisoned and maintained in the manner prescribed by law.

WHEREUPON, the defendant was remanded to the Western Regional Jail.




