**ORDER RE-SENTENCING DEFENDANT AND
APPOINTING APPELLATE COUNSEL**

This Court is in receipt of an Order from the West Virginia Supreme Court of Appeals directing the Court to appoint counsel and re-sentence the petitioner, Jason W. Holstein, for purpose of filing a petition for appeal.

The defendant stands convicted upon a plea of guilty entered in this Court on April 12, 2010 to the charge of First Degree Murder, as contained in Court Four of Felony Indictment Number 09-F-389.

A disposition hearing was held on this matter on June 30, 2010, and the Court

ORDERED as follows:

09-F-389 Count Four: That the defendant, **JASON W. HOLSTEIN**, be sentenced and confined in the penitentiary of this State for the rest of his natural life, with credit for time spent in jail awaiting trial and conviction, with credit for time so spent in jail is five hundred twenty-four (524) days as of the date of the sentencing hearing.


WHEREUPON, the prisoner was remanded to the Division of Corrections and a written order was entered.


Upon receipt of an order from the West Virginia Supreme Court of Appeals, this Court hereby **ORDERS** that the aforesaid sentence is re-imposed. This Court further **ORDERS** that the defendant be appointed appellate counsel for the purposes of filing an appeal. Specifically,

the Court hereby **ORDERS** that **SAMUEL D. MARSH** is appointed to represent the defendant in this matter.

It is **FURTHER ORDERED** that the Clerk of this Court send a certified copy of this Order to all parties, counsel of record, the Prosecuting Attorney of Kanawha County, and the Division of Corrections
