**SENTENCING ORDER**

On the 7th day of May, 2015, came the defendant, **JESSICA MAY WILSON**, together with counsel, Charles Hamilton and Brady Campbell, and also came the State of West Virginia by Fred J. Giggenbach, Jr., and Tera Salango, Assistant Prosecuting Attorneys in and for Kanawha County, West Virginia, for sentencing in this matter upon the defendant's oral and written plea of guilty to the Felony offense of First Degree Murder, as contained in Count Four of Felony Indictment Number 14-F-228, entered in this Court on the 10th day of April, 2015.

THEREUPON, it was demanded of the said **JESSICA MAY WILSON**, if anything she had or knew to say why the Court should not now proceed to pronounce the sentence of the law against her, and no valid reason being offered or alleged in delay of judgment, it is **CONSIDERED** and **ORDERED** by the Court that the defendant, **JESSICA MAY WILSON**, be sentenced to confinement in the penitentiary of this State for her natural life, without mercy, plus court costs.




It is further ORDERED that the Clerk send a certified copy of this Order to all counsel of record, South Central Regional Jail, and the Department of Corrections.
