AMENDED ORDER OF COMMITMENT

On this the 22nd day of January, 2019, came the attorney for the State of West Virginia, and the defendant appearing in person and represented by Courtenay Craig, Esquire.

It is ADJUDGED that the defendant was found guilty by a jury in the offense as charged in case number 17-F-14: Count II-Possession with Intent TO Deliver a Controlled Substance. The Court, having asked the defendant whether he has anything to say why judgment should not be pronounced, and no sufficient cause to the contrary being shown or appearing to the Court, it is ADJUDGED that the defendant is guilty as charged and convicted. It is ADJUDGED that the defendant is hereby committed to the custody of the Warden of the West Virginia Penitentiary or his authorized representative for imprisonment for a period of: One to Fifteen (1-15) Years in the custody of the West Virginia Department of Corrections.

It is ADJUDGED that the defendant pled guilty of the offense as charged in case number 18-F-275: 3rd Offense of a Felony (Habitual Offender/Recidivist). The Court, having asked the defendant whether he has anything to say why judgment should not be pronounced, and no sufficient cause to the contrary being shown or appearing to the Court, it is ADJUDGED that the defendant is guilty as charged and convicted. It is ADJUDGED that the defendant is hereby committed to the custody of the Warden of the West Virginia Penitentiary or his authorized representative for imprisonment for a period of: Life with Mercy in the custody of the West Virginia Department of Corrections to run CONCURRENT WITH 17-F-14.


