What can WV E-File Order Templates do for you?

WV E-File Order Editor **Template** options:

- **(Form).rtf**: Inserts (adds) data in case AND creates body of Order
- **.rtf**: Inserts (adds) data in case, but does NOT create body of Order

Template [prompts filer](#) to insert order language required for Title IV-E [grant funding](#) for the State of WV, in Juvenile cases.

- **Title IV-E Findings.rtf** Template prompts:
 - **Order of First Removal Findings:**
 - It is contrary to the welfare of the child to remain in the child's home.
 - It is in the best interest of the child to be removed from the child's home.
 - The child is without proper care, custody, or support and immediate protective custody is necessary to prevent personal harm to the child.
 - The removal from the home is/was necessary to protect the child.
 - The child is being neglected and is without proper care and supervision.
 - The child's condition (or the circumstances surrounding the child's care) requires that custody be immediately assumed to safeguard the child's welfare.
 - The child will commit or attempt to commit other self-injurious offences.
 - The child is in immediate danger of imminent serious physical injury or sexual abuse.

TIP: Fullscreen button works as toggle between Fullscreen view (**Maximized** Order Editor) and Exit of Fullscreen view (**Minimized** Order Editor).

How do I access Templates?

Where to Create an **Order**:

- **Proposed Orders → Proposed Order** – Case (Rtf Editor)
 - Select **Templates** button via **Order Editor** tab
- **Proposed Orders → Proposed Order** – Motion (Rtf Editor)
 - Select **Templates** button via **Order Editor** tab

**Most Commonly Used Order Templates folder:

- **Miscellaneous:** Root → State Templates → Miscellaneous

How do I import a drafted Order into the Order Editor?

WV E-File Order Editor **Import** options:

- **Form (Insert):** Inserts content from uploaded document into Order Editor at location of cursor when Import button is selected.
Note: Form (Insert) works with templates and does not replace manually entered text or content.
- **Body (Replace Template):** Deletes all content in Order Editor (Exceptions: Auto-generated Case Style, Title, and Judge's signature), then Inserts content from uploaded document into body of Order.
Note: Body (Replace Template) replaces templates, text, and imported content.

How do I create Orders using Templates?

How to Create a **Final Divorce Order** via Template:

- Click **Templates** button
- Select **Divorce.rtf** Template via State → Miscellaneous folder
- Import using **Import (Form)** option and/or draft Order in Editor
- **File Order**

Data added into case upon submission of **Final Divorce Order by the Judge:

- ✓ Date of Divorce automatically populated in case.

How to Create an **Order Setting Bond** via Template:

- Click **Templates** button
- Select **Set Bond.rtf** or **Set Bond (Form).rtf** Template via State → Miscellaneous folder
- Import using **Import (Form)** option and/or draft Order in Editor
- **File Order**

Data added into case upon submission of **Set Bond Order by the Judge:

- ✓ Bond Type
- ✓ Bond Description
- ✓ Created Date
- ✓ Bond Amount
- ✓ Bond Status = Set

How to Create a **Bond Modification Order** via Template:

- Click **Templates** button
- Select **Modify Bond.rtf** or **Modify Bond (Form).rtf** Template via State → Miscellaneous folder
- Import using **Import (Form)** option and/or draft Order in Editor
- **File Order**

Data added into case upon submission of **Modify Bond Order by the Judge:

- ✓ Modified Bond Type
- ✓ Modified Bond Amount

How to Create a **Sentencing Order** via Template:

- Click **Templates** button
- Select **Sentencing.rtf** or **Sentencing Bond (Form).rtf** Template via State → Miscellaneous folder
- Import using **Import (Form)** option and/or draft Order in Editor
- **File Order**

Data added into case upon submission of **Sentencing Order by the Judge:

- ✓ Sentenced Charges
- ✓ Assessed Costs
