PARTIAL DISMISSAL ORDER

This Mallinckrodt plc, Mallinckrodt LLC, Mallinckrodt came Brand

Pharmaceuticals, Inc., Mallinckrodt Enterprises LLC, SpecGx LLC, Defendants in the above-

captioned case, and by their Notice of Bankruptcy Discharge (Transaction ID 67968981) filed in

Master Case No. 19-C-9000 on August 24, 2022, informed this Court that they have substantially

consummated their reorganization plan under chapter 11, title 11 of the United States Code, and

therefore all claims against them in this proceeding have been permanently enjoined and

discharged. Accordingly, this proceeding should be closed as to these Defendants.

Upon consideration of the foregoing, the Court is of the opinion to and does hereby

ORDER that Defendants Mallinckrodt plc, Mallinckrodt LLC, and SpecGx LLC each be

dismissed from this action, with prejudice.
