AMENDMENT TO E-FILING AND SERVICE CASE MANAGEMENT ORDER TO ADD MANUFACTURER CASES MASTER CASE NUMBER

On August 4, 2021, the Mass Litigation Panel granted Plaintiff's motion to sever the

above-styled cases for an expedited bench trial (Transaction ID 66821121). To facilitate

electronic filing and service in these cases, the Court hereby amends the Electronic Filing and

Service Case Management Order (Transaction ID 63504553) entered on July 2, 2019, to add a

separate Master Case File for the above-styled cases.

The Court has directed File & ServeXpress to structure the new Master Case File as

follows:

The Manufacturer Cases Master Case file shall contain only pleadings or documents of

general applicability to the Manufacturer Cases, such as trial calendars, case management

orders and other orders of general applicability, joint motions, notices of deposition if they are

not case-specific, master pleadings, master discovery, and other similar documents.

When a document is intended to be applicable to all manufacturer cases, the document

shall be styled "In re: Opioid Litigation, Civil Action No. 21-C-9000 MFR", shall contain the

notation "THIS DOCUMENT APPLIES TO ALL MANUFACTURER CASES" and shall be

filed into Case Number MC 21-C-9000 MFR.

When a document is intended to be applicable to a specific manufacturer case, the

document shall be styled "In re: Opioid Litigation, Civil Action No. 21-C-9000 MFR", shall

contain the notation "THIS DOCUMENT APPLIES TO:" and the specific manufacturer case

shall be listed using the initiating case number and three-letter county identifier of the case into which the document is to be filed.

All other provisions of the Court's *Electronic Filing and Service Case Management Order* (Transaction ID 63504553) remain in full force and effect.
