**VOLUNTARY DISMISSAL ORDER DISMISSING THE DEPARTMENT
OF HEALTH AND HUMAN RESOURCES WITH PREJUDICE**

NOW COME the aforementioned Plaintiffs, by counsel, and notify the Court, pursuant to West Virginia Rule of Civil Procedure 41(a)(1)(ii), that they wish to voluntarily dismiss all claims asserted, or that could have been asserted, in the aforementioned civil actions against the West Virginia Department of Health and Human Resources (“WVDHHR”). The aforementioned Plaintiffs wish to dismiss any and all claims against the WVDHHR, with prejudice.

All parties that have appeared in the action have agreed and consented to these dismissals, as evidenced by the signatures of counsel of record affixed hereto.

Based upon the foregoing notice, the Court does hereby adopt the aforementioned stipulations and does hereby **DISMISS**, with prejudice, the claims of Plaintiffs against the WVDHHR; with each party to bear its own costs and expenses, including attorney’s fees, incurred in this action. The claims against the DHHR are hereby stricken and dismissed in their entirety with prejudice. The remaining claims are not affected by this Order.

It is so **ORDERED**.
