This matter having come before the Court on January 10, 2020, on Plaintiffs’ Motion to Approve Settlement and the Court having **GRANTED** said motion (Transaction ID 64616788), it is hereby **ORDERED** that the claims and actions against Liggett Group LLC, Liggett & Myers Inc. and Brooke Group Ltd. (the “Liggett Defendants”) in each of the above referenced matters are **DISMISSED WITH PREJUDICE** with each party to bear their own attorneys’ fees and costs.
