**FIRST AMENDED CASE MANAGEMENT ORDER
REGARDING DAMAGES ONLY TRIAL**

The Presiding Judges have reviewed the *Joint Motion for Clarification or Modification of Case Management Order Regarding Damages Only Trial* (Transaction ID 61369946) filed on November 16, 2017. Finding good cause shown, the Presiding Judges GRANT the motion and

ORDER the following amendments to the *Case Management Order Regarding Damages Only Trial* (Transaction ID 61341803):

1. Fact and expert witness depositions may be taken **up to and including January 30, 2018.**
2. Exhibits, Witness Lists and Deposition Designations shall be exchanged **no later than February 9, 2018**, with any objections thereto **no later than February 23, 2018.** All parties shall meet and confer **no later than February 26, 2018**, to resolve objections to witnesses, exhibits and deposition designations.

All other deadlines set forth in the *Case Management Order Regarding Damages Only Trial* (Transaction ID 61341803) remain in full force and effect, including but not limited to, the March 12, 2018, pretrial conference and hearing on dispositive motions and motions *in limine*, and the March 19, 2018, trial. Any objection or exception to this Order is noted for the record.
