ORDER OF DISMISSAL WITH PREJUDICE

All cases listed in the attached Exhibit A are hereby dismissed *with prejudice*, with each party to bear its own costs. This Order does not apply to:

1. the 92 cases in which Plaintiffs have pending claims against Defendant Liggett Group, LLC, as listed in Exhibit A to the *Amendment to Pending Claims Against Defendant Liggett Group* (Transaction ID 61683940);
2. the 30 cases in which Plaintiffs allege they smoked ventilated filter cigarettes between 1964 and July 1, 1969, as listed in Exhibit A to the *Amendment to Phase II Plaintiffs List* (Transaction ID 61685762); and
3. the 41 cases in which Plaintiffs allege they used smokeless tobacco products, as listed in Exhibit A to the *Amendment to Report Regarding Humphrey Farrington & McClain, P.C. Smokeless Tobacco Cases* (Transaction ID 61683978) and the *Identification of James Humphreys' Plaintiffs with Smokeless Tobacco Claims* (Transaction ID 59234118).

Pursuant to West Virginia Trial Court Rule 24.01, the parties have five (5) days from the date of the Court's Order to file and serve any objections to the Order.

It is so **ORDERED**.
