STIPULATION AND ORDER OF DISMISSAL WITH PREJUDICE AS TO AMNEAL DEFENDANTS

All Plaintiffs, including Plaintiffs listed on Exhibit A (hereinafter "Plaintiffs"), and Defendant Amneal (including Amneal Pharmaceuticals, Inc., Amneal Pharmaceuticals LLC, Amneal Pharmaceuticals of New York, LLC, Impax Laboratories, Inc., and as defined in Section II.L of the Amneal Pharmaceutical Settlement Agreement dated May 25, 2023), by and through their respective counsel, hereby inform the Panel that all claims between Plaintiffs and Amneal in all civil actions filed by Plaintiffs in the *In Re: Opioid Litigation*, including Civil Action No. 19-C-9000, and all Civil Action Nos. listed on Exhibit A, have been amicably resolved in good faith and settled, and Amneal is to be dismissed with prejudice. Therefore, Plaintiffs, Amneal, as well as each West Virginia local government who elected to participate in the respective Amneal Pharmaceutical Settlement Agreement, which is binding on Plaintiffs and all participating West Virginia local governments, hereby stipulate to the dismissal of all claims against Amneal WITH PREJUDICE, with each party to bear its own costs and attorneys' fees.
