REPLY TO COUNTERCLAIM OF YORK BUILDING PRODUCTS CO., INC. and YORK BUILDING AGGREGATES, LLC

by its counsel, states the following Reply to the Counterclaims alleged by Defendants YORK BUILDING PRODUCTS CO., INC. and YORK BUILDING AGGREGATES, LLC (collectively, the "Defendants" or "York") in their *Answer and Counterclaim* filed December 7, 2016:

PNGI denies all factual allegations and legal conclusions set forth by York in numbered paragraphs 1-25 of its Answer, to the extent those factual allegations and legal conclusions differ from the facts and legal conclusions as alleged in PNGI's Complaint or seek to otherwise explain or deny York's liability in this matter. PNGI further denies all factual allegations and legal conclusions set forth by York in the affirmative defenses section of its pleading, labeled First Affirmative Defense through Fifteenth Affirmative Defense, and denies that any of York's affirmative defenses have factual support or legal merit. As to the numbered paragraphs of York's Counterclaim, PNGI replies as follows:

- 14. PNGI denies all allegations, legal conclusions, demands, and requests for relief contained in York's *Answer and Counterclaim* that are not specifically admitted by PNGI in this Reply.

15. PNGI asserts all affirmative defenses available to it under applicable law, as the same may be supported by the facts alleged or as developed in this case.

WHEREFORE, the Plaintiff respectfully requests that the Defendants' Counterclaim be dismissed, that the Plaintiff be awarded its costs and fees expended in defense thereof, and such further relief as the Court deems just.
