DEFENDANTS' RESPONSE TO PLAINTIFF'S MOTION TO REFER TO THE BUSINESS COURT DIVISION

For reply to Plaintiff's request that this matter be submitted to the Business Court Division, the Defendants answer and say:

This case is not suited for, nor cases of this nature were ever intended to be submitted to a Court dealing with business. This is a rental case. There was never a signed Lease, thus the rent is only on a month to month basis. The rent allegedly due on a month to month basis is offset by issues of leakage from the roof, and others having access to the premises, thus destroying the quiet enjoyment of title afforded to the defendants herein.
