## JUDICIAL REPLY TO MOTION TO REFER CASE TO THE BUSINESS COURT DIVISION

Pursuant to Rule 29.06 of the West Virginia Trial Court Rules, the Honorable James A. Matish, Judge for the Fifteenth Judicial Circuit, respectfully submits his reply to the motion that the above-styled Civil Action No. 18-P-235-3, currently pending before the Circuit Court of Harrison County, Division 3, be referred to the Business Court Division.

The petition in this case was filed on December 17, 2018. The State answered the petition on January 8, 2019, and the County answered on February 1, 2019. A motion to refer this matter to the Business Court Division was filed on September 18, 2020.

The principal claim in this case involves a matter of significance regarding a valuation of Antero's Harrison County gas wells. Specifically, Plaintiff claims (1) that the Harrison County Board of Assessment Appeals incorrectly upheld the valuation of Antero's Harrison County gas wells by the West Virginia Department of Revenue, State Tax Department, Property Tax Division for the 2018 tax year and (2) that the valuation of Plaintiff's gas wells should be reduced to \$229,324,824.

This Court agrees with this referral because the disputes to be tried involve complex issues of tax valuations in the oil and gas industry. A court with specialized knowledge of the subject matter, and familiarity with the specific law and legal principles of tax valuations, will be able to provide this matter with appropriate specialized treatment. Such treatment would certainly improve the expectation of a fair and reasonable resolution of the controversy. The claims involve complex tax appeals, which are eligible to be referred to the Business Court Division under West Virginia Trial Court Rule 29.04(a)(3). Additionally, the Court is unaware of any related actions currently pending, or if any such actions will be filed in the future.
