## JUDICIAL RESPONSE TO MOTION TO REFER TO THE BUSINESS COURT DIVISION

Pursuant to Rule 29.06 of the West Virginia Trial Court Rules, the Honorable James A. Matish, Circuit Judge for the Fifteenth Judicial Circuit, respectfully submits his response in the above-styled Civil Action No. 20-C-209-3, currently pending before the Circuit Court of Harrison County, Division 3, to a motion that the case be referred to the Business Court Division.

The complaint in this case was filed on August 18, 2020. The Defendant responded with a motion to dismiss the complaint on September 23, 2020. The Defendant moved to refer this case to the Business Court Division on November 5, 2020. The Plaintiff responded on November 24, 2020, stating that it did not object to this case being referred to the Business Court Division.

The principal claim in this case involves certain dealings between the Defendants and CityNet, LLC, an Internet service provider with its base of operations

in Bridgeport. Plaintiff claims that Defendants tortiously and fraudulently obtained confidential information belonging to Plaintiff from CityNet, to the detriment of Plaintiff's business.

This Court has no objection to referral to the Business Court Division. The disputes to be tried involve complex issues relating to business torts, corporate structure and operations, and information technology. Specialized treatment by a court with specialized knowledge of the subject matter and familiarity with the specific law and/or legal principles relating to these issues will certainly improve the expectation of a fair and reasonable resolution of the controversy. The claims involve complex tort claims, which are eligible to be referred to the Business Court Division under West Virginia Trial Court Rule 29.04(a)(1) and 29.04(a)(2). Additionally, the Court is unaware of any related actions currently pending or if any such actions will be filed in the future, other than Defendants' representation that litigation is pending in Florida.

The Court has served a copy of the Motion on all parties specified in Rule 29.06(a)(3): John F. Gianola, Counsel for Plaintiff, Robert J. D'Anniballe, Jr., Counsel for Defendants; Albert Marano, Circuit Clerk of Harrison County; and the Central Office of the Business Court Division.
