TRIAL COURT RULE 22 SCHEDULING ORDER

Plaintiff filed its Complaint in this matter in Harrison County Court on August 18, 2020.

On September 22, 2020, Defendants filed their Motion to Dismiss Plaintiff's Complaint with an attendant memorandum in support of their Motion.

On November 5, 2020, Defendants moved to refer this case to the West Virginia Business Court Division. On November 24, 2020, Plaintiff responded stating that it did not object to this matter being referred to the Business Court Division.

On December 30, 2020, the Supreme Court of West Virginia Ordered this matter transferred to the Business Court Division.

On January 12, 2021, the Honorable Judge Nines was assigned to this matter as presiding Judge and the Honorable Judge Young was assigned to this matter as resolution Judge.

On February 10, 2021, Judge Nines and the parties conducted a scheduling and status conference. At said conference, a briefing schedule for Defendants' Motion was determined to be in the best interest of the Parties.


Therefore, the following is ORDERED:

- a) Plaintiff shall file (if not already filed) and serve its response to Defendants' Motion to Dismiss by **March 1, 2021**.
- b) Defendants shall file (if not already filed) and serve any reply to Plaintiff's response by **March 8, 2021**.
- c) A hearing on Defendants' Motion shall be held on **April 2, 2021**.
- d) This Order shall serve as any required Notice of Hearing under the West Virginia Rules of Civil Procedure or the West Virginia Trial Court Rules and Defendant shall NOT be required to serve any other notice of said hearing unless and until said hearing is continued to another day or time.

ENTER this 1st day of March, 2021.


