ORDER CONTINUING TRO AND ESTABLISHING BRIEFING SCHEDULE

By motion dated April 9, 2021, ERP Environmental Fund, Inc. ("ERPEF") moved for the entry of a temporary restraining order and sanctions, asking this Court to, *inter alia*, enjoin Investment Management Group, LLC ("IMG") from attempting to alter, interfere with and/or discontinue the terms of the Reclamation Services Agreement ("Agreement") between the parties, in violation of this Court's Order. On April 12, 2021, the Court entered the "Order Granting Motion for Temporary Restraining Order of ERP Environmental Fund, Inc." This Order directed that any responses to the relief requested be filed on or before April 15, 2021. Consistent with this directive, Investment Management Group, LLC filed its Response on April 15, 2021, preliminarily objecting to entry of the Temporary Restraining Order and requesting until May 3, 2021, to submit a full response to ERPEF's Motion.

The Court held a telephonic status conference on the matter on April 19, 2021. Prior to the status conference, the Court was advised that IMG and ERPEF have agreed to continue the TRO pending further briefing and a hearing on the relief sought by ERPEF without IMG waiving any argument, factual or legal, regarding the scope, extent, or validity of the Temporary Restraining



Order and ERPEF's request that it be converted to a preliminary injunction. The Court therefore ORDERS the following:

- 1. IMG shall respond to ERPEF's April 9, 2021 Motion, on or before May 3, 2021;
- 2. ERPEF shall file any reply to IMG's response on or before May 13, 2021; and
- 3. After the conclusion of briefing, the Court will determine whether any further hearing is necessary and, if so, will set the hearing date at that time.

The Court notes the objection of any party aggrieved by this Order.
