ORDER GRANTING MOTION TO RESCHEDULE STATUS CONFERENCE

Motion to Reschedule Status Conference filed by Defendants.

By Order entered August 18, 2021, this Court entered an Order Granting Joint Motion to Stay Proceedings and Order Setting Hearing, wherein it granted the parties' agreed motion to stay proceedings due to medical issues regarding one of the Defendants and granted the parties' joint request for status conference. By that Order, the Court set the requested status conference for Friday, September 24, 2021 at 1:00 p.m. via Microsoft Teams.

On September 14, 2021, Defendants filed the instant Motion to Reschedule Status Conference, seeking to reschedule the status conference for a date after October 4, 2021, after a medical appointment of the Defendant wherein he is expected to receive an update on his ability to participate in this litigation.


The Court, finding good cause shown, hereby GRANTS the instant motion. Further, the Court, considering the docketed October 14, 2021 hearing date that was scheduled if the parties were to need it for a hearing on dispositive motions, finds that the remote status conference set for Friday, September 24, 2021 at 1:00 p.m. shall be CONTINUED until October 14, 2021 at 1:00 p.m. to be held remotely via Microsoft Teams. Thus, the tentative dispositive motions hearing scheduled for October 14, 2021 at 1:00 p.m. in the courtroom of the undersigned in the Greenbrier County Courthouse shall be CONVERTED into a remote status conference.

Accordingly, this matter shall come on for a remote status conference October 14, 2021 at 1:00 p.m., before the Honorable Jennifer P. Dent for a status conference via Microsoft Teams. Participation information will be sent to all counsel of record.

Wherefore, it is hereby ADJUDGED and ORDERED that the Motion to Reschedule Status Conference is hereby GRANTED.
