AGREED ORDER EXTENDING MEDIATION DEADLINE

This day came Plaintiff/Crossclaim Defendant The Thrasher Group, Inc. ("Thrasher") and Defendants/Crossclaimants Bear Contracting ("Bear") and Great American Insurance Company ("Great American"), by and through their respective counsel, pursuant to Rule 29 of the *West Virginia Rules of Civil Procedure*, and agreed to the extension of the deadline for mediation, as set forth in the Court's Scheduling Order entered on March 1, 2021, as follows:

1. The mediation deadline shall be extended from October 15, 2021 to January 21, 2022.
2. The trial of this matter is scheduled to begin on April 4, 2022; therefore,

extending this deadline will not affect either the pre-trial hearing date or the trial date as stated in the Scheduling Order.

WHEREFORE, hearing no objection, the Court does hereby **ORDER** that the deadline for mediation as stated in the Court's Scheduling Order are hereby **AMENDED** and extended as:

1. Mediation shall be completed on or before January 21, 2022.


