AGREED ORDER MODIFYING SCHEDULING ORDER and OTHER DEADLINES

This day came the parties, by their respective counsel, and informed the Court that the parties are working toward formalizing the terms of a definitive settlement agreement in this matter. The parties jointly requested that the pending discovery be held in abeyance until November 5, 2021, and that the discovery completion date set forth in the Order Setting Pretrial and Trial Schedule be changed to December 6, 2021, with all other scheduling order deadlines remaining in place so as to allow counsel a period of thirty days to complete and execute a definitive settlement agreement. Furthermore, the Defendant's Partial Motion for Summary Judgment is pending, and Plaintiff's response to same is due October 12, 2021.¹ The Parties jointly requested that the pending motion be held in abeyance and that Plaintiffs' response to same be due on November 11, 2021.

Accordingly, it is hereby ORDERED that all pending discovery matters are suspended and held in abeyance until November 5, 2021, and that the discovery completion date shall be

December 6, 2021. It is further ORDERED that Plaintiffs' response to Defendant's Partial Motion for Summary Judgment is due on November 11, 2021. It is further ORDERED that counsel shall inform the Court no later than November 5, 2021, as to the status of a definitive settlement agreement.
