ORDER GRANTING MOTION OF RECEIVER FOR ENTRY OF ORDER
AUTHORIZING RECEIPT OF SUBSIDENCE
ESCROW FUNDS FROM TIMOTHY DIXON, ESQUIRE

By motion of October 8, 2021, the Special Receiver and Timothy Dixon, in-house counsel to a former affiliate of ERP Environmental Fund, Inc. ("ERP"), jointly sought permission of the Court for Mr. Dixon to transfer—and for the Special Receiver to receive—certain escrow funds (totaling \$200,000) that were previously set aside by ERP Environmental Fund, Inc. ("ERP") to cover claims of potential subsidence damage to a residential structure above one of ERP's underground mines in Marion County, WV.

Both the Receiver and Mr. Dixon agree that the \$200,000, plus interest, currently escrowed in Mr. Dixon's attorney escrow account is the property of the Receiver and should be turned over to the Receiver in accordance with paragraphs 15 and 16 of the Receivership Order, less any bank fees for closing the segregated bank account and wiring the funds to the Receiver.

Having reviewed the motion and heard such parties as desired to be heard, the Court hereby GRANTS the motion and FINDS and ORDERS as follows:

(i) The Court directs Mr. Dixon to the transfer the \$200,000, plus interest, less bank fees, to the Receiver promptly after this Order becomes final and non-appealable; and

(ii) The Court further orders that the \$200,000, plus interest, less bank fees, shall be held by the Receiver and may not be accessed or acted against by any person, including any persons with liens, claims, or other encumbrances against the Receivership Estate, until further order of the Court regarding proper disposition of the funds.
