AGREED ORDER GRANTING PLAINTIFFS' MOTION FOR SUBSTITUTION OF PARTIES

Before the Court is the motion of Plaintiffs, Lewis Clark Tierney, III, et al. ("Plaintiffs") to substitute Katherine K. Combs, as Personal Representative of the Estate of Carolyn K. Tierney Griesemer, for Plaintiff, Carolyn Kenna Tierney Griesemer. A Suggestion of Death of Plaintiff Carolyn Kenna Tierney Griesemer was filed on August 31, 2021.

As indicated by the parties' joint submission of this Agreed Order, no party objects to Plaintiffs' Motion for Substitution of Parties, filed on November 11, 2021 ("Motion"), and the Court takes the matter under submission without hearing. Pursuant to Rule 25(a)(1) of the West Virginia Rules of Civil Procedure, "[i]f a party dies and the claim is thereby not extinguished, the court may order substitution of the proper parties." W. Va. R. Civ. Pro. 25(a)(1) in part. Furthermore, "[t]he motion for substitution may be made by any party or by the successors or representatives of the deceased party." Id.

Having considered the arguments of the parties, all applicable authorities, and the record as a whole, and there being no objection thereto, the Court hereby GRANTS Plaintiff's Motion

and ORDERS that Katherine K. Combs, in her capacity as Personal Representative of the Estate of Carolyn K. Tierney, be substituted for Plaintiff Carolyn Kenna Tierney Griesemer.
