This matter came before the Court upon the Joint Motion for Status Conference filed by the parties.





Further, the Court considers that in the instant motion, the parties jointly proffer that they do not currently have sufficient time to complete discovery, which is currently scheduled to close on March 15, 2022. *See* Joint Mot., ¶¶1, 4. Recognizing the status conference is set for a date later than March 15, 2022, it is further hereby ORDERED that the deadlines in the Court's Agreed Order Amending the Scheduling Order entered on January 21, 2022 are hereby VACATED and, furthermore, the trial and pretrial dates are hereby CONTINUED. The Court orders that these aforementioned dates and deadlines in the instant civil action be continued

generally until the parties and the Court can conduct scheduling at the status conference on April 4, 2022.
