## ORDER GRANTING PLAINTIFFS' GLADE SPRINGS VILLAGE PROPERTY OWNERS ASSOCIATION, INC.'S MOTION FOR EXPEDITED HEARING

This matter came before the Court this 6th day of April 2022. The Plaintiff, Glade

Springs Village Property Owners Association, Inc., by counsel, has filed a Motion for Expedited

Hearing With Regard to Glade Springs Village Property Owners Association, Inc.'s Verified Motion for Temporary Restraining Order And Preliminary Injunction Regarding That Certain Cart Path Between The No. 1 Tee And The No. 18 Green. The Plaintiff, Glade Springs Village Property Owners Association, Inc., (hereinafter "Plaintiff" or "the POA"), by counsel, Ramonda C. Marling, Esq., has filed the instant motion and Defendant, GSR, LLC, (hereinafter "Defendant" or "GSR"), by counsel, Arie M. Spitz, Esq., has filed a Response. So, upon the full consideration of the issues, and relevant law, the Court rules as follows.

The Plaintiff filed its Verified Motion for Temporary Restraining Order And Preliminary Injunction Regarding That Certain Cart Path Between The No. 1 Tee And The No. 18 Green on April 1, 2022. The hearing on this motion is currently set for April 15, 2022 at 10:00 a.m.

The instant motion seeks an expedited hearing date, and proffers April 8, 2022 for a hearing. In Response, GSR avers that counsel for GSR will be unavailable the week of April 15, 2022, including on April 15, 2022, but is available April 8, 2022 or April 19, 2022.
