ORDER GRANTING MOTION OF RECEIVER FOR ENTRY OF ORDER AUTHORIZING SALE CERTAIN PIECES OF EQUIPMENT FREE AND CLEAR OF LIENS, CLAIMS AND ENCUMBRANCES

Accordingly, the Special Receiver may sell the Dozer free and clear of all liens and encumbrances.
