#### AMENDED AGREED JUDGMENT ORDER

Petitioner and Counterclaim Defendant, Frasure Creek Mining, LLC ("Frasure Creek"), Respondents, Counterclaim Plaintiffs, and Third-Party Plaintiffs, Pocahontas Land, LLC and Pocahontas Surface Interest, LLC ("Pocahontas"), and Third-Party Defendants Deep Water Resources, LLC ("Deep Water") and New Trinity Coal, Inc. ("New Trinity") (collectively, the "Parties"), announced to this Court that the claims that were asserted or could have been asserted against the Parties in Civil Action No. 20-C-142(B) have been resolved. Based on this settlement and compromise, the Parties jointly file this Amended Agreed Judgment Order. The Parties agree as follows:

- 1. Pocahontas initiated an arbitration against Deep Water and New Trinity in relation to a coal lease on Pocahontas' property and coal mining operations conducted by Frasure Creek.
- 2. On February 22, 2022, an Arbitration Panel consisting of G. Nicholas Casey, Christopher Pence, and John F. McCuskey entered an arbitration award in the amount of \$2,248,912.57, bearing interest of 4% until paid, against Deep Water and New Trinity, as guarantor, in favor of Pocahontas ("Arbitration Award").
  - 3. On March 18, 2022, Pocahontas moved to confirm the February 22, 2022

arbitration award.

4. Pursuant to West Virginia Code § 55-10-24, a party "may make a motion to the

court for an order confirming [an arbitration] award" upon receiving notice of the award. Upon

the motion, "the court shall issue an order confirming the award unless the award is modified or

corrected pursuant to sections twenty-two or twenty-six of this article or is vacated pursuant to

section twenty-five of this article." See also W. Va. Code § 55-10-25(a)(1)-(6) (allowing

vacation of an arbitrator's award in six limited situations: (1) the award was procured through

fraudulent means; (2) evident partiality, corruption, or misconduct by the arbitrator; (3)

arbitrator's refusal to postpone the hearing or consider material evidence as to substantially

prejudice the rights of a party; (4) an arbitrator exceeded his or her powers; (5) there was no

agreement to arbitrate; or (6) the arbitration was conducted without proper notice).

5. The Parties agree that the Arbitration Award should be confirmed pursuant to W.

Va. Code § 55-10-24.

Having considered the parties' filings and for the reasons stated above, this Court

GRANTS Pocahontas' Motion to Confirm Arbitration Award and CONFIRMS the Arbitration

Award and enters **JUDGMENT** in the amount of \$2,248,912.57, with interest at 4% until entry

of this judgment, and, thereafter, post-judgment interest at the statutory rate until paid, against

Deep Water and New Trinity in favor of Pocahontas, consistent therewith. The Arbitration

Award is fully enforceable in the State of West Virginia as if it had been entered by a West

Virginia Circuit Court. This Court further **ORDERS** that the claims asserted by the Parties are

hereby **DISMISSED**, with prejudice. There being nothing further, this Court does **ORDER** that

the above-styled action be **DISMISSED** and **STRICKEN** from the docket of this Court.
