ORDER DISMISSING MOTION TO QUASH AND MOTION FOR PROTECTIVE ORDER AGAINST GSVPOA'S NOTICE OF VIDEOTAPED DEPOSITION OF KENT BURGER; NOTICE OF DEPOSITION OF J. NEFF BASORE; AND FIRST AMENDED NOTICE OF VIDEOTAPED 30(B)(7) DEPOSITION OF COOPER LAND DEVELOPMENT, INC. IN CIVIL ACTION NO. 21-C-129 AND SECOND AMENDED

This matter came before the Court upon the Motion to Quash and Motion for Protective Order Against GSVPOA's Notice of Videotaped Deposition of Kent Burger; Notice of Deposition of J. Neff Basore; and First Amended Notice of Videotaped 30(b)(7) Deposition of Cooper Land Development, Inc. in Civil Action No. 21-C-129 and Second Amended Notice of Videotaped 30(b)(7) Deposition of Cooper Land Development, Inc. in Civil Action No. 19-C-357. The instant motion was filed August 19, 2022 by Defendants Elmer Coppoolse, James Terry Miller, and R. Elaine Butler, averring counsel for those Defendants was not available on the dates/times of the contested notices of deposition. On August 24, 2022, a Briefing Order was entered.

In its Response in Opposition to Defendant Justice Holdings LLC's Motion to Quash GSVPOA's Notices of Videotaped Deposition of Kent Burger, J. Neff Basore, and First Amended Notice of Videotaped 30(B)(7) Deposition of Cooper Land Development, Inc., Plaintiff, Glade Springs Village Property Owners Association, Inc., averred that the instant motion has now been rendered moot as the it voluntarily did not move forward with the contested depositions. *See* Pl's Resp., ¶16. No Reply was filed.

Finding that this matter appears to be resolved, the instant motion shall be DISMISSED as MOOT. The motion is dismissed without prejudice.

CONCLUSION

Accordingly, it is hereby ADJUDGED and ORDERED Defendants Elmer Coppoolse,

James Terry Miller, and R. Elaine Butler's Motion to Quash and Motion for Protective Order

Against GSVPOA's Notice of Videotaped Deposition of Kent Burger; Notice of Deposition of J.

Neff Basore; and First Amended Notice of Videotaped 30(b)(7) Deposition of Cooper Land

Development, Inc. in Civil Action No. 21-C-129 and Second Amended Notice of Videotaped 30(b)(7) Deposition of Cooper Land Development, Inc. in Civil Action No. 19-C-357 is hereby DISMISSED WITHOUT PREJUDICE AS MOOT.
