ORDER

On the 7th day of November 2022, came Plaintiff/Counterclaim Defendant, The Thrasher Group Inc. ("Thrasher"), by its counsel, Adam S. Ennis and John D. Pizzo, and Defendants/Counterclaimants, Bear Contracting, LLC ("Bear") and Great American Insurance Company ("GAIC"),¹ by their counsel, Christopher A. Brumley and Evan S. Aldridge, for a telephonic status conference to discuss the status of this case and proposed revisions to the schedule in this matter. In addition, the Parties informed the Court that they have a tentative partial settlement framework in place as it relates to certain claims and counterclaims. For the reasons more fully discussed on the record, the Court concludes and finds as follows:

SCANNED

1. The Parties shall have until November 28, 2022, to file any dispositive motions. Such dispositive motions shall be no more than thirty (30) pages in length.

2. Responses in opposition to any dispositive motions shall be due by December 19, 2022.

3. Replies in support of any dispositive motions shall be due by January 6, 2023.

4. The deadline for expert depositions is extended until January 31, 2023.

5. A hearing on any dispositive motions shall be held on February 1, 2023, at 11:00 a.m.

6. The Court will conduct a pretrial conference in this matter on March 1, 2023.

7. Trial in this matter will remain on the previously established dates of March 20-29, 2023.

8. All proceedings in this matter will take place at the Putnam County Judicial Building in Winfield, West Virginia.

It is so **ORDERED**.




