

JUDICIAL REPLY TO MOTION TO REFER CASE TO THE BUSINESS COURT DIVISION

Pursuant to Rule 29.06 of the West Virginia Trial Court Rules, the Honorable James A. Matish, Judge for the Fifteenth Judicial Circuit, respectfully submits his reply to the motion that the above-styled Civil Action No. 20-C-231-3, currently pending before the Circuit Court of Harrison County, Division 3, be referred to the Business Court Division.

The Complaint in this case was filed on September 14, 2020. MVB Bank filed its Answer on October 22, 2020. Jarrod Furgason filed his Answer and Affirmative Defenses on November 2, 2020. A motion to refer this matter to the Business Court Division was filed on June 7, 2021.

The principal claim in this case involves a matter of significance regarding banking, insurance, and securities. Specifically, Plaintiff claims that Defendants induced Plaintiffs to take out a life insurance policy, which involved a complicated scheme of providing funds to different banking institutions to obtain loans,

culminating in the purchase of an insurance policy and insurance premium financing. The majority of the money invested by Plaintiffs to secure the loan to obtain financing was to be returned to Plaintiffs within so many days after closing for the loan; however, Plaintiffs state that the financing was not obtained and the funds were not returned to Plaintiffs. Instead, Plaintiffs allege, the funds paid by Plaintiff were distributed among Defendants and their agents.

This Court agrees with this referral because the disputes to be tried involve complex issues of securities, banking, and insurance financing. A court with specialized knowledge of the subject matter, and familiarity with the specific law and legal principles of securities will be able to provide this matter with appropriate specialized treatment. Such treatment would certainly improve the expectation of a fair and reasonable resolution of the controversy. The claims involve complex commercial and technological issues, which are eligible to be referred to the Business Court Division under West Virginia Trial Court Rule 29.04(a)(2). Additionally, the Court is unaware of any related actions currently pending, or if any such actions will be filed in the future.
