DEFENDANT OVERLAY I, LLC'S RESPONSE TO THE ORDER OF THE SUPREME COURT OF APPEALS OF WEST VIRGINIA

COMES NOW, Defendant, Overlay I, LLC ("Defendant"), by and through its counsel, Gregory E. Kennedy, Esquire, and the law firm of Franklin & Prokopik, and hereby files its Response to the Order of the Supreme Court of Appeals of West Virginia dated March 17, 2020, as follows.

As this Court is aware, this civil action is currently pending in the Circuit Court of Berkeley County, West Virginia before the Honorable Bridget M. Cohee (20-C-110), who, on February 26, 2021, filed the Judicial Motion to Refer Case to the Business Court Division ("Judicial Motion") pursuant to Rule 29.06 of the West Virginia Trial Court Rules. Specifically, the Judicial Motion detailed the nature of the civil action and attached a copy of the Complaint, the docket sheet, and the Defendant's Motion to Dismiss, which has yet to be ruled on. Finally, the Judicial Motion stated that the parties would benefit from expedited review from the Business Court and requested that this Court grant the Judicial Motion without responses.

In turn, on March 17, 2021, the Chief Justice, by order of same date, determined that responses to the Judicial Motion are necessary for consideration of the same, and directed the parties to file a response on or before April 2, 2021 ("Order").

In response to the Order, Defendant states that it supports the Judicial Motion and believes that the referral to the Business Division of this matter will be in the best interest of the parties due to the complexity of the underlying issues raised in Plaintiff's Complaint and Defendant's Motion to Dismiss. Additionally, the Defendant notes that its Motion to Dismiss has not been ruled upon, and it hereby requests that a hearing and ruling on the same be heard and determined by the Presiding Judge assigned to this matter upon this Court's entering of an order granting the Judicial Motion for assignment to the Business Court Division.¹

WHEREFORE, Defendant, Overlay I, LLC, hereby submits its Response to the Order of the Supreme Court of Appeals of West Virginia dated March 17, 2021, and seeks the entry of an order by this Court referring this matter to the Business Court Division, and staying action on Defendant's Motion to Dismiss so that the same may be heard and determined by the Presiding Judge, and any other relief this Court deems proper and just.
