
As I believe you are aware, my wife and I have mineral interests here in Marshall County which were leased to Chevron in 2014, renewed by Chevron in 2019 and assigned to EQT in November, 2020.

At that time, pursuant to West Virginia Trial Court Rule 17.03, I was able to transfer all EQT cases to the Honorable David W. Hummel, Jr. for further action. However, I am aware that Judge Hummel has recently voluntarily recused himself from further presiding over EQT cases.

I have inquired and have been informed that EQT still holds our mineral lease. Therefore, I am requesting that I be permitted to recuse myself from presiding over the above matters and a special judge be appointed to the same.
