**AGREED ORDER DISMISSING CLAIMS BY  
AND AGAINST CENTURY ENGINEERING, INC.**

On this 5<sup>th</sup> day of FEB, 2015, came the parties, by and through their respective counsel, and represented to the Court that all claims filed by and against Century Engineering, Inc. in this matter have been settled pursuant to a separate Settlement Agreement and Release and that those claims, and Century Engineering, Inc., should be dismissed from this case.

**WHEREFORE**, this Court acknowledges the settlement of all claims made by and against Century Engineering, Inc. in this matter, and **ORDERS** as follows:

A. Century Engineering, Inc.'s Cross-Claim against Grant Architects, Inc. is hereby noted as settled and dismissed, without prejudice, pending fulfillment of the terms of the separate Settlement Agreement and Release entered into between the parties; the Court acknowledges the intention of the parties to file a subsequent notice with the Court dismissing this claim with prejudice upon the fulfillment of those terms;

B. Grant Architects, Inc.'s Cross-Claim against Century Engineering, Inc. is hereby noted as settled and dismissed, with prejudice;


C. Century Engineering, Inc.'s Counterclaim against Associated Specialists, Inc. and POB, LLC is hereby noted as settled and dismissed, with prejudice;

D. Any and all claims of Associated Specialists, Inc. and/or POB, LLC against Century Engineering, Inc. are hereby noted as settled and dismissed, with prejudice, pursuant to the "Order Granting Defendants' Motions to Dismiss [Second] Amended Complaint" entered on April 7, 2014, and the "Order (Re: "Defendant Century Engineering, Inc.'s Rule 59 Motion to Alter or Amend Judgment")" entered on July 2, 2014;

F. Each party is responsible for paying its own attorney's fees and costs of this proceeding;


G. The Circuit Clerk of Harrison County is directed to submit a certified copy of this Order to all counsel of record.
