Rogers, II, Prosecuting Attorney for Ritchie County, West Virginia, who has for its answer to the

Complaint herein the following:

- 1. Pursuant to West Virginia Rule of Civil Procedure 9(d), the County Commission of Ritchie County, which sat as the Board of Assessment Appeals in the underlying matter, hereby avers that all its official acts, including but not limited to the denial of the appeal of certain tax assessments by the Petitioner herein, were taken in compliance with law.
- To the extent that the Complaint of the Petitioner filed herein avers that said denial of its appeal of certain tax assessments as therein alleged was erroneous, the County Commission of Ritchie County denies the same.
- 3.
