The Circuit Clerk is directed to send a certified copy of this order to all counsel of record.

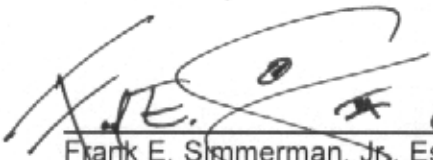

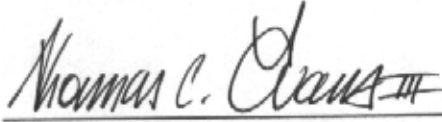
AGREED ORDER DISMISSING ALL CLAIMS ASSERTED BY WEST VIRGINIA RADIO
