AGREED ORDER EXTENDING THE DISCOVERY DEADLINE


On July 31, 2015, came the Plaintiffs, by counsel, Gregory H. Schillace and the Defendant, by counsel, Michael J. Farrell and Christina L. Smith, and pursuant to Paragraph 12 of this Court's July 28, 2014 Amended Scheduling Order, presented this Court with this Agreed Order Extending the Discovery Deadline seeking authorization from this Court to extend the Discovery Deadline in this matter. Paragraph 8 of this Court's Amended Scheduling Order set a Discovery completion deadline of August 17, 2015. The parties, by counsel, represented to this Court that counsel are currently working together on scheduling depositions in this matter and that due to scheduling conflicts and the number of witnesses to be deposed, the parties will need additional time to complete the depositions. Therefore, the parties request that this Court extend the discovery deadline to September 8, 2015.

After consideration of the Agreed Order Extending the Discovery Deadline, this Court determined that there is good cause to extend the time period and therefore the Agreed Order Extending the Discovery Deadline is **APPROVED** and the parties are **GRANTED** an extension of the discovery deadline up through and including September 8, 2015.




