AGREED ORDER DISMISSING ALL CLAIMS ASSERTED BY WEST VIRGINIA RADIO

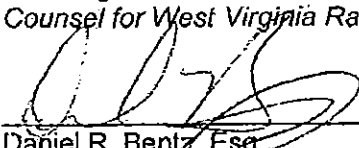

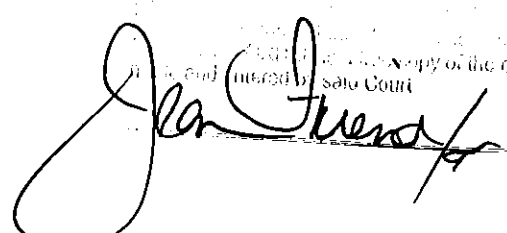
