

ORDER RESCHEDULING PRETRIAL CONFERENCE

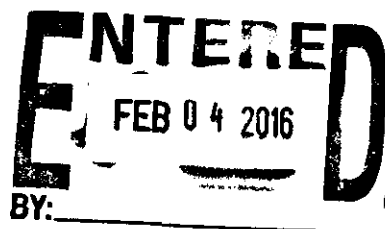


