**ORDER**

This matter comes before the Court pursuant to a Stipulation of Voluntary Dismissal filed by the Plaintiff, The Velotta Company, by and through counsel, and agreed to the Defendant/Third-Party Plaintiff, Stantec Consulting Services, Inc., by and through counsel, and Third-party Defendant, CTL Engineering of West Virginia, Inc., by and through counsel. The parties have informed the Court that they have reached a compromise and have settled all matters remaining in dispute in the above captioned matter and wish to dismiss, with prejudice, all claims before the Court.

THEREFORE, pursuant to West Virginia Rule of Civil Procedure 41(a)(2), the Court has undertaken a review of the case and Stipulation of Dismissal. The Court finds the terms and conditions of the dismissal proper and hereby accepts the voluntary dismissal of the parties. ACCORDINGLY, it is hereby ORDERED that the above-referenced matters are each DISMISSED WITH PREJUDICE as agreed as to all parties, with each party to bear its own

attorneys' fees and Plaintiff to bear all court costs. This being a FINAL ORDER, the Court directs the Circuit Clerk of Upshur County to retire the above-captioned matter from the docket and place it among the causes ended. The Circuit Clerk of Upshur County is directed to distribute attested copies of this Order to all counsel of record; the Resolution Judge, the Honorable James J. Rowe at the Greenbrier County Courthouse, P.O. Box 751, 912 Court Street North, Lewisburg, WV 24901; and the Business Court Division Central Office, Berkeley County Judicial Center, 380 W. South Street, Martinsburg, West Virginia 25401.


