**ORDER FOLLOWING MARCH 4, 2016 HEARING**

On a previous day, the Court received the "Plaintiff's Motion to Compel and for Contempt" and set the matter for hearing on March 4, 2016. Plaintiff attended by and through counsel, Nicholas S. Preservati. No other party appeared. Mr. Preservati represented to the Court that he had received a notice of bankruptcy for Mr. Kelly, but not Ms. Kelly or the company defendants.

Accordingly, the Court ORDERED upon the record that Mr. Kelly provide the Court with documentation from the bankruptcy court in order to demonstrate that he is a party to an ongoing bankruptcy proceeding by April 1, 2016. Additionally, the Court ORDERED the Defendants to file a notice of appearance for counsel of the defendants by April 1, 2016, and cautioned that a failure to do so could result in default judgment. Lastly, the Court RESET the hearing on the Plaintiff's Motion to Compel and for Contempt for April 6, 2016, at 2:00, to be held at the Cabell County Courthouse before the Honorable Paul T. Farrell.
